

If you are not the person that I previously communicated with regarding the information below, then I wholeheartedly apologize for the intrusion. I only ask that you let me know.

You and I had spoken via e-mail late last year (November, December). You had entered some information in the Mutual UFO Network (MUFON) database regarding your involvement in picture taking whereby President John Kennedy had met with an alien. I had e-mailed you subsequent to your report and asked you some questions. You responded with a few answers (which I appreciate). I applaud your courage in stepping forward with your story. I have taken upon myself to look more deeply into this case because I believe your story.

You are wondering how I got your address. I found your address on a national search engine. I can assure you that I have not revealed your name to anyone as I know that you want anonymity. I will also say that I don't think that anyone will harm you as the result of your story (as you indicated in your MUFON report). Many top government officials and ex-military personnel have recently come forward regarding UFO secrecy. Dr. Steven Greer has obtained over 100 witnesses who have had first-hand experience with UFO's within the government. None of these witnesses have been harmed.

With all of that being said I am asking you for some more information about your experience. I will list each question and provide plenty of space for your reply. You can fill in these questions and mail in a self addressed stamped envelope which I have enclosed. If you choose not to respond, I will understand and I will not attempt to contact you again. However, your information could be critical in solving the UFO controversy. I urge you to respond. Any new information will be helpful.

1. Do you know the approximate date that you photographed President Kennedy talking (or other interaction ) with the alien? A month and year would suffice, but if you know whether it was early or late in the month, that would help.

2. I would like to know the type of airplane that flew you to the airfield where the picture session took place of President Kennedy meeting with the alien. Did it take off from Adair Station? How long was the plane ride? Did you know any of the persons who accompanied you (including the pilot)? Were these people in civilian or military clothes? How many were there?

3. Why did you suspect that the individual that President Kennedy was speaking was alien? What did the creature look like? Was it humanoid looking? Did you see the creature come out of a craft? Take off in a craft? What did the craft look like? Do you know where the airfield was located? Were any other people with President Kennedy? Was the airfield abandoned (no other people around)?

4. How long were you at the airfield? What did you do with the pictures? Did you develop them yourself?

5. Did you know the names of any of these government officials at the scene? Have any of them went public with their story?

I realize that you are taking risks answering these questions. I assure that I am a MUFON Investigator and that I have no connections with any covert government agency. (I am on your side.) I will not reveal your name to anyone without your permission. No stories will be written about this incident without your permission, review, and approval. Your name will not be revealed in any report of this incident.
